- **The Oldfield Golf Course**, Signature Greg Norman Golf Course Design, is a 7,142-yard, par 72 course. The course is complemented by a Golf Shop, the Clubhouse with grille, private dining areas, and locker rooms.
 - **The Oldfield River Club** offers opportunities to dine on Friday evenings. This restored home is positioned under majestic Live Oaks on the banks of the Okatie River.
 - **The Magnolia Grill** offers opportunities to dine casually, offering lunch Tuesday-Saturday, Grab n' Go Lunch & Bar Service on Sundays and dinner on Thursday evenings.
 - The Club hosts special events and activities designed exclusively for our Golf Members, such as:
 - Member/Member Tournament Spring and Fall
 - Ryder/Solheim Cup in March
 - Holiday Tournaments though-out the year
 - Member/Guest in October

Non-Resident Golf Fees

Non-Resident Golf Membership Dues

One Time Capital Reserve Fee \$1,500

One Year Monthly Dues - \$420 monthly with a 12-month loyalty agreement

Three Year Monthly Dues - \$400 monthly with a 36-month loyalty agreement
(\$2,000 nonrefundable deposit required and used toward the last 5 months of the 3rd year)

Young Executive Dues (35 and younger)

One Time Capital Reserve Fee \$1,500

One Year Monthly - \$350 monthly with a 12-month loyalty agreement

Three Year Monthly - \$333.33 monthly with a 36-month loyalty agreement
(\$2,000 nonrefundable deposit required and used toward the last 6 months of the 3rd year)

Greens and Cart Fees

While there are no greens fees for golf members; Annual Golf Members are responsible for daily cart fees when riding. Presently cart fees are \$13/\$26 for 9 or 18 holes.
